



## Dual Degree Program MSW/MBE

- 1. Overview
  - a. The MSW/Masters in Bioethics (MBE) is a dual degree program sponsored by the University of Pennsylvania School of Social Policy and Practice and the Center for Bioethics at the University of Pennsylvania. The aim of the dual degree program is to prepare students to be leaders in bioethics-related, research-based program and policy venues in the social services, life sciences and medicine. This dual degree program blends the like missions and values of social work and medicine for equitable service provision, knowledgeable development of ethical policies, and just decision making in the 21st century global environment of rapid technological and social change.
  - b. Students will have the opportunity to earn both degrees in two years (two academic years and two summers).
  - c. This program is intended to:
    - Provide valuable tools for social workers in local, state, and national venues.
    - Expand the range of frameworks applicable to decision making in matters of bioethics and social policy and practice.
    - Stimulate interdisciplinary collaboration in research, policy making, and implementation.
- 2. Application Process
  - a. Students apply first to the School of Social Policy and Practice, and only upon acceptance to the Penn MSW program should students apply for the MSW/MBE dual degree.
    - i. Students applying to the MBE may use the same letters of recommendation used for the MSW application.
    - ii. The MBE degree requires no GRE or other standardized test scores.
    - iii. A separate application fee is required for the MBE degree.
  - b. The MSW/MBE degree is open only to full-time MSW students on the clinical or macro practice track.
- 3. Degree Completion Requirements
  - a. In order for a student to receive both degrees, he or she must complete the independent degree requirements of each program.
    - i. For Social Work
      - 1. Students must complete 16 CUs for the MSW portion of the degree:
        - a. SW 601, 602, 603, 604, 611, 612, 613, 614, 701, 702,
        - 704/708, 714/718, 715, 744 and BIOE 601 and 602.
    - ii. For the MBE program
      - 1. Students must complete nine course units toward the MBE portion of the degree. Of these, students take six course units in the Department of Medical Ethics (BIOE 601, 602, 996, and 3

electives) and three course units at the School of Social Work (SW 701, 702, and 744).

- iii. Combining non-course requirements from both programs
  - 1. Students have two options after completion of SW 744.
    - a. If the final paper for SW 744 relates to Bioethics, the student can petition it to count as BIOE 996, the final project for the MBE.
      - i. Students who would like to count SW 744 as their MBE final project must submit a Petition for Action and receive approval from the Director of Graduate Studies prior to the semester in which the writing is to be done.
      - ii. If the student chooses this option, then they may take a BIOE elective instead of BIOE 996
    - b. Alternatively, the topic discussed in SW 744 can be built upon and completed as BIOE 996, the final project for the MBE.
  - 2. Given the above, the following table illustrates how the double counting works:

- 5. Tuition and Financial Aid

  - c. Financial aid decisions are made by the School of Social Policy and Practice alone.
  - d. The Department of Medical Ethics does not offer any financial aid, grants, or scholarships.
- 6. Scheduling Courses
  - a. Students register for courses in one program in that program's registration period and according to that program's registration rules and procedures.
  - b. The timing and location of course scheduling must also be considered so that students are best able to attend all classes.
